OLD BUSINESS:

- Ash tree in the Cemetery on South Road. Dennis checked out the tree. It looks to be well foliated. Only a
 few lower branches are barren. It appears healthy and doesn't appear to be infected by the Emerald Ash
 Borer (EAB) pest. Photos emailed to Greg Jordan. On 8-27-20 he stated that the tree could be treated.
 Following research on EAB treatments and timing, Commission members agreed to treat this tree in
 the spring, as trunk injections are most effective when done in April-May timeframe (vs. fall).
- 2. Tilton Land extension & Subdivision is still being reviewed by the Planning Board. On Agenda this Thursday.
- 3. Vicki Pollinator Pathways NH now has 14 town partners and more than 500 likes on Facebook. Upcoming in-person events include a wildflower walk in Kingston Sept. 9, and the 2nd annual seed exchange in the fall.
- 4. Bank Restoration along the Powwow River. Hope for comments from Chris Albert at Jones & Beach for the next meeting.
