Minutes of Meeting June 19, 2023

The CC meeting was Called to Order at 5:04pm.

NEW BUSINESS:

EKCC is concerned that proposed NH DES wetlands regulations requiring numerous signatures prior to any Conservation Commission site visit (currently permitted with the signatures on the permit) is "problematic at best and prohibitive at worst." We agreed to communicate our concerns to NHACC by June 30 and to NH DES as public comment by 4pm July 10; Adam will draft the letter for review.
