The EKCC supports the purchase of the land for a conservation easement, provided the boundary marker is replaced and following a site visit. Jeremy will follow up accordingly and also schedule a Public Hearing concurrent with an EK Select Board meeting.
- 2. 9 Bowley Road / New England Outdoor Materials. Midnight Leasing LLC. Dennis shared 19 comments about the Site Plan from a town engineer POV. We discussed additional concerns, including light industrial zoning, AOT (Alteration of Terrain), dyes and chemicals use, unapproved removal of vegetation and leveling within 250' of the Powwow River, debris and trash, potential water pollution, etc.
- 3. Carter property at 68 South Road. Change to approved lot lines Approved at last Planning Board Meeting.
- 4. Conservation Properties Prioritization. Tabled.
  - a. Water Supply Potential factor. We'll ask Emma to join us in October instead of September.
  - b. Cultural/historical/scenic factor.
