Chairman Smith called the meeting to order at 7:30 PM. He called upon Beverly Fillio, Alternate, to be a voting board member.

## PUBLIC HEARING:

The Chairman opened the meeting for a public hearing in the case of the proposed Telecommunications Facilities Ordinance. There were no members of the public present for comment or discussion, and the Board pursued its own line of inquiry. Discussion included clarification on Mrs. Sarah Campbell's request that any motion include provision for the ordinance's numbering, the ordinance itself and its paragraphs, to be brought into conformity with the existing ordinances.

Discussion concluded with a change to the last sentence of paragraph X. REMOVAL OF ABANDONED ANTENNAS AND TOWERS. The original wording was "The Town may require that the applicant and/or owner provide annual proof of operation (including but not limited to safety inspections, insurance binders)." The revised wording is to be "The Town requires the applicant and/or owner provide annual proof of operation (including but not limited to safety inspections, insurance binders)."

<u>MOTION</u>: Mrs. Fillio moved to approve the Telecommunications Facilities Ordinance, with the noted administrative change to the last sentence of the REMOVAL OF ABANDONED ANTENNAS AND TOWERS paragraph, renumbering the entire ordinance to accommodate existing ordinances, for placement on the ballot as a warrant article for the East Kingston Town Meeting 1997. Mrs. George seconded. The motion was carried (5-0).

CORRESPONDENCE: Chairman Smith noted correspondence from the Rockingham Planning Commission announcing an informational meeting at the Kingston Town Hall, 7:00 PM, February 13, 1997, regarding the safeguard of local watershed and habitat. The public are invited, and Mr. Day expressed an interest in attending. Mrs. Fillio suggested we move right along.

MINUTES: Mrs. George moved the minutes from the January 30, 1997, Flanning Board meeting be accepted. Mrs. Fillio seconded. The motion was carried (5-0).
