This is an official hearing of the East Kingston Board of Adjustment. The hearing is called tonight at the request of FMR, Inc. and FMR is seeking an appeal from an administrative decision. They allege that an error has been made in a decision by the building inspector on 12/29/88. The application fails to identify the article and section of the Zoning Ordinance under which the alleged administrative decision was incorrectly made. But instead refers to a law of the State of New Hampshire regarding manufactured housing. And this is signed by a Marshall N. Decker.

Now the way we conduct our Board of Adjustment hearings, we will give the applicant an opportunity to present his case. The fact that this is an appeal to an administration decision, we will ask the applicant to state the exact nature of the default and then the Board will be able to consider whether or not an incorrect administrative decision was made.
