

- Sherry is printing out the checklists on Monday at the Town Offices


Changes to past minutes based on voter info (public v/ private). Sherry intends to upload 2023 and future minutes to the SoC webpage after the March elections.


- SSN to be validated; person is registered

- Sherry will redact the past minutes and attach redacted print-outs for any future Right to Know requests.




