The Town of East Kingston is seeking sealed bids beginning September 15, 2023 and ending on September 30, 2023 for the purchase of the town's 1992 American General M998 Blue. The vehicle currently has 16,782 miles on it. The tires on the vehicle are severely dry cracked and will not pass New Hampshire State Inspection. The fuel tank also leaks. This vehicle does run. There are no front doors with it. This vehicle is not equipped with EPA emissions equipment.

All bids shall be submitted in duplicate, in a sealed envelope clearly marked: "1992 American General M998 bid" on the outside of the envelope. Bids shall be received no later than 1200 hours on September 30, 2023. Bids shall be delivered or sent to the Town of East Kingston, Board of Selectmen's Office, 24 Depot Road, East Kingston, NH 03827.

The bidder is responsible for submission prior to the date and time specified. There will be no public opening of the bids. Bids will be opened on or after the bid due date and time. All bids become the property of the Town of East Kingston. The Town of East Kingston reserves the right to reject any and all bids on any basis and without disclosure of reason.

Please note:

This property was either on the U.S. Munitions List (USML) or on the Commerce Control List (CCL). CCL may require a general or validated license from the Department of Commerce prior to export. These are typically “dual” use type items, in that they have both a military and civilian use and are usually identified as DEMIL Code Q.

It is the exporter’s responsibility to ensure the property is correctly classified and all appropriate licenses are obtained prior to exporting the property.

Please keep in mind that the USML and CCL surplus property may actually be in great demand by some individuals or countries and could be used against the United States. Exporting or assisting anyone to illegally export property is a serious criminal offense and could result in substantial fines and/or imprisonment.

Please note that you are required to inform subsequent purchasers of this property of this restriction. Documentation reflecting resale should be available for review if requested. You are expected to cooperate with Government representatives to verify the existence and condition of USML/CCL. The Office of Defense Trade Controls (DTC), US Department of State, controls and provides guidance on the export and temporary import of defense articles and defense services covered by the US Munitions List. These include final action on license applications for defense trade exports, defense trade compliance, enforcement, and reporting. DTC also provides guidance on registration, applications status, and export law compliance for defense export approvals. DTC administers and enforces the International Traffic in Arms Regulations (ITAR) (22 C.F.R. Parts 120-130) and Arms Export Control Act (AECA) (22 C.F.R. 2778-2780).
